Each year, the State Council of Higher Education for Virginia (SCHEV) reports data on new transfers to Virginia higher education institutions for the previous fall. A review of the data shows that 300 students transferred from LFCC to four-year, in- state institutions in fall 2013. This number has grown 73.4% from 173 in 1999. The fall 2013 transfer number dropped -5.9% from a high of 319 in 2012.

Cumulatively, 3,449 LFCC students have transferred since 1999. The largest percentage has gone to JMU (20.2%), followed by George Mason (15.5%), Shenandoah University (13.7%), Old Dominion (11.6%), Virginia Tech (8.3%), and Radford (6.4%).

Since 1999, approximately 822 (23.8%) of all transfers go to private schools, primarily Shenandoah (471) and Liberty University (116). The number of LFCC students going to private colleges fell -24.4% from 86 in fall 2012 to 65 in fall 2013, mostly at Shenandoah which went from 34 in 2012 to 22.


Among public institutions, JMU has historically been home to the most LFCC transfers with 697, followed by GMU (536). For fall 2013, public college transfers were topped by GMU with 53, followed by JMU (50), ODU (35), Virginia Tech (28), and Radford (18). ODU's transfers dropped from a school high of 46 in fall 2012 to 35 in fall 2013, while Virginia Commonwealth University declined from 18 to 13 and Mary Washington University went from 9 to 15.

Since 1999, approximately 41.4% (1,429) of all LFCC students earned an associate's degree before transferring. Among all associate's degree holders since 1999, 28.6% went to JMU.

Among the 300 transfers in fall 2013, 138 (46.0%) held the associate's. For fall 2013, 64.0% (32) of JMU transfers held an associate's degree. This compares to Virginia Tech (57.1%), UVa (55.6%), Mary Washington (53.3%), ODU (51.4%), and GMU (49.1%). In contrast, the percentage of transfers with associate's degrees to private colleges was 33.3% at Shenandoah and 28.6% at Liberty.




## Trends in Fall Transfers by Institutional Control






## Trends in Fall Transfers for Primary Institutions






Fall 2013 Transfers by Associate's Attainment by Institution
